Vail - Dec 9 to 16. \$1,349 per person, double.

This trip is full and any other space will be on request only. However there is an opening for one male. If you are interested, please request the space as soon as possible.

Aspen - Jan 9 to 16. \$1,499 per person, double.

There is room at the hotel for 10 more people but our air allotment is sold out. I will have to request air for any further reservations. I'll have to drop the unsold rooms by Nov 9 to avoid underutilization penalties.

Club Med - Alpes d'Huez, France, \$2,149 per person

This trip is totally all-inclusive. You can leave your wallet home! Club Med will not hold any rooms without a deposit after Oct 15. After that date, it is subject to cancellation penalties. We have been very conservative in booking space. We currently have some space available but it must be released by Oct 15 at the latest!

Steamboat - Mar 6 to 13, \$1,499 per person, double

Big Sky - Mar 30 to Apr 6, \$1,299 per person, double
